Currency Review

To be WFC current and eligible to rent an aircraft, a pilot must have flown in the last 90 days (30 days for students).

After 90 days (30 days for students) of not flying, a club instructor check ride is required to reinstate currency.

For each make and model of aircraft (Cherokee, Archer, Super Hawk), a club instructor check out is required An Archer checkout is <u>NOT</u> considered to include a Cherokee checkout. A check out need not be repeated to reinstate currency however the 12 month check out/additional ratings requirement must be met.

Currency as written in the club by laws

Section 1 All pilots must pass an oral and flight examination by a club instructor paralleling the FAA requirement when any of the following conditions arise:

- a) any new member whether a rating is held or not.
- b) every 12 months, for each club member before s/he can fly club aircraft except when additional ratings have been acquired, or another type of check ride has been taken which has been approved by the Board of Directors, in which case, the date for the next check ride is (12) months from the date s/he acquired the rating or took the approved check ride.
- c) a member wishes to fly an aircraft in which s/he has not been previously checked out.

Section 2 All private pilots must successfully complete a check ride in a club airplane by a club instructor if they have not flown within the previous 90 days. Student pilots must complete a similar check ride if they have not flown within the previous 30 days.

Flight Rx Adult Vaccinations by Dr. Pam Tarkington

Right now we are in the middle of a "flu crisis" so let's talk about that vaccine as well as others.

Influenza vaccine: recommended for everyone over 6 months of age. It is recommended for those who recently had influenza.

Contraindications: those with severe analphylaxic reaction to chicken eggs or the vaccine and those that develop Guillan Baree within 6 weeks of vaccination and those with severe illness with fever. Older people are at a higher risk for the flu and death. Over 30,000 die in this country each year from influenza. Those given the live attenuated vaccine should stay away from people who are immunecompromised for a week. Less than 1% develop flu like symptoms. Basically, it is safe - get it. You cannot get the flu from the vaccine.

Pertussis: (whooping cough): adults > 65 who have never received T dap should get a single injection.

Varicella (chicken pox): all adolescents and adults who have not had a previous infection should get the vaccine. Women should wait 1 month after getting this vaccine to become pregnant.

Zooster (shingles): recommended for all over 60 years of age even if they have had shingles in the past. The only contraindications are severe immunodeficiency and pregnancy. Shingles is extremely painful and this can last for years. Contraindicated in those with immunodeficiency state.

Measles, mumps, rubella (MMR): it should be given to all children at 12-15 months of age and adults born before 1957. Some need a second dose. Wait 4-6 weeks to get pregnant.

Penumococcal (pneumonia): everyone > 65 years old as well as all smokers and those with asthma >19. Also those with a cochlear implants, cardiovascular disease, HIV, ETOH abuse, splenic disease, chronic renal disease, pulmonary disease, diabetes, immune suppress lymphoma and hypertension. Re-vaccination after 5 years age 19-65; over 65 another booster, 60-80% effective. No more than 1 booster is necessary.

Hepatitis A: kids 1-18 years old. Not generally used in adults unless adopting foreign born kids.

Hepatitis B: 19-59 with diabetes: get it. There are 3 doses. Wait 6 weeks before donating blood as when they test your blood it will test positive for hepatitis B.

Obviously this article has only covered adult vaccinations. All vaccinations - including those given in childhood - are safe. In this country certain diseases (pertussus, polio) were essentially wiped out until some got the wrong idea that the vaccines caused diseases (autism, etc) - this is totally wrong.

There are widespread cases of the flu this year because eligible people are not being vaccinated.

- 1. Loss of Revenue (due to our loss of FAA funding).
- 2. Keep our Club growth up / retain current members keep active in recruitment.
- 3. How do we get our current private pilots (non-students) flying more

The solution is a two-fold answer in that if we keep our membership up & get our current member pilots flying revenue will continue to grow. Now how do we do this?

- The Nicoletta loan will be paid off next quarter, transition that money in to an airport fund and find other ways to add to that fund.
- I would like to introduce a 'Fly Buddy' program for our current pilots & students: I get the sense that many of our membership almost feels lost. In that this is a club but they don't feel like they are really part of it.
- Come up with more club activities (other than the pancake breakfast & Saturday lunch in Jakes hanger). Using the fly buddy program I would offer up some ideas such as leaf peeper flights in the fall, club planned flights to 'other airport' fly-ins. Get groups of our people together go out as a CLUB share in the expense of flying and along with that share in the flying duties as well. less expense per pilot should equal more hours flown which then means more revenue for the club.
- I get the feeling the ONLY real time members are asked to come to the club is to help with work at the club. I would offer up that the BoD take a day and do a CLUB appreciation day.

Where the BoD does a cook out offer up an informal Q & A session, maybe even offer up games that type of thing. Make it more of a family atmosphere going forward too.

So that in a nutshell would be my suggestions from the 10,000 foot level.
